## The Canadian German Chamber of Industry and Commerce reinforces its strong support for CETA

MONTREAL, March 31 /CNW Telbec/ - On March 29<sup>th</sup>, 2011 the Canadian German Chamber of Industry and Commerce Inc. (CGCIC) hosted a reception in Montreal, QC to reinforce its strong support for a Comprehensive Economic Trade Agreement (CETA). He encouraged the Canadian and German governments to continue to pursue policies that would further increase the ability of businesses to compete around the world, now, and in the future and especially to strongly support CETA.

Mr. Pierre Lortie, Senior Business Advisor at Fraser Milner Casgrain LLP and former President and COO of Bombardier Transportation stressed the importance of the agreement for Germany and Quebec and appealed to both countries to take action. The negotiations between Canada and the European Union towards CETA are going into the 7<sup>th</sup> round this April. A broad based agreement is projected to benefit the Canadian economy by \$12 billion.
